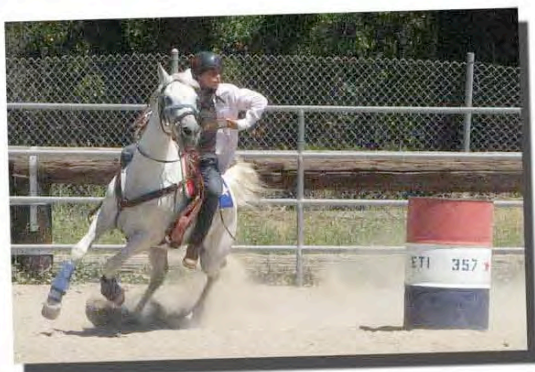

# HORSE TALES

In 2002 my family and I decided it was time to look for the Palomino we had always wanted. It was to replace my first horse, a Sorrel, who had died of cancer. Our first thought was a horse trader located in our area since they have a large number and large assortment of horses. This particular horse trader also leases horses to camps for children, a plus for kid proof rides, which is what we were looking for.

Upon our arrival the owner sized us up to see what type of riders we would be. Out of 200+ head of horses she pulled out two. One was a yellow horse with a kind face, but looked beat up and had bite marks all over as horses do in a herd.

We saddled him up and I rode him around a bit, through water, around flapping scary things and out through the property by ourselves to see how he would react. Both the horse and I were very comfortable together, so I took him back to the ranch and while I was talking to the owner, he put his head under my arm and just stood there. That action sealed the deal and we took him home. We named him Chance as we were “taking a chance on another horse!” Chance was purchased as a 6-year-old ranch horse, but when I had a vet look at him he thought Chance was only 4 and was told he still had 2 more years of growing. Chance is now 15.3 and 1500lbs.

I knew from being around horses for 20 years that he was not a Palomino. His eyes, skin color and hoof coloring were different. I asked around and every opinion I received was that he was a Palomino. A cowboy friend told me back home “We just call him a yellow horse.”

I spent about four months (off and on) on the Internet trying to find his coloring and finally I hit on a color site that had a link to the ICHR. The ICHR site was packed full of information and it fit Chance’s description. My color quest was over. He is a Gold Champagne. I have been searching for Chance’s origins as he has two brands, but have come up with nothing except that he probably originated in New Mexico.

Chance is a traffic stopper and the center of attention. He is a fun horse to own and stands out in a crowd. Chance was used in an advertisement for an outdoor gear company and a clothing store advertisement. They needed a horse that was a good contrast for their black and orange gear. Chance is a character, he opens the other horses stall doors (I have used three different latches). He plays with cones and buckets—throwing them over fences so we can throw them back and I’ve even seen him playing tug of war with my other horses with a cone through the bars. He loves attention and wants to be top dog – well horse. He has a mustache that’s very noticeable (so is mine!). We half expect him to start talking one day- guess the neighbors do too – they call him Mr.Ed! (See photo on page 7)

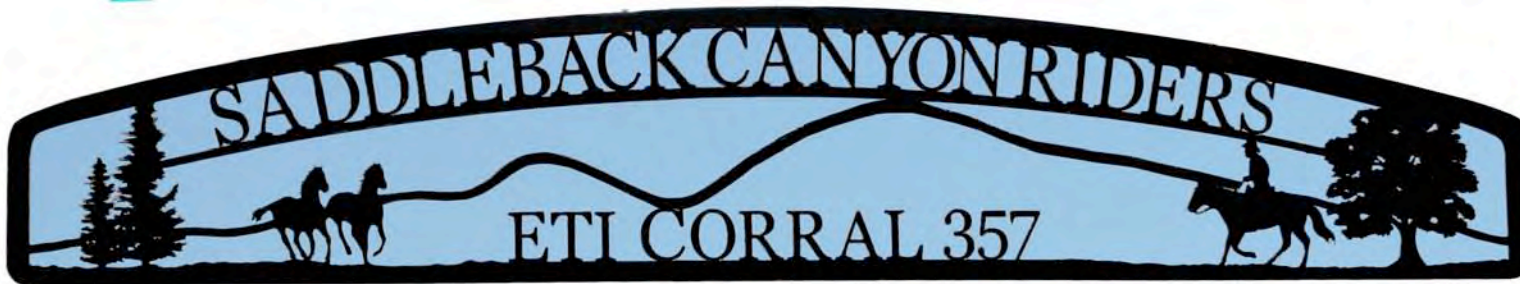
# EMERGENCY RESPONSE TEAM REPORT

Several members in ETI are involved in an annex group attached to MAU and the Emergency Response Team (ERT). We met with Orange Count Fire Authority and representatives for OC Animal Care in April. The purpose of this meeting was to continue or efforts to officially integrate with Animal Care, and augment their efforts during an emergency in Orange County. We are primarily focusing on large animal evacuation, but with the participation of SCART (Surf City Animal Response Team) located in Huntington Beach, we proposed that smaller, companion animals and their owners would benefit from a volunteer group response group. SCART has numerous resources to quickly respond. Under this proposal all responders will be under the OC Animal Control Incident Command System (ICS). The MAU/ERT had training for ICS in January and it is now an annual requirement. Much of the above information was included in an earlier ETI newsletter, but we wanted to bring everyone up to date. We will be meeting again in July as we decided quarterly meetings would be appropriate. We are hoping to eventually move these meetings to the Emergency Operations Center (EOC) where we would also have representatives from that facility. Michelle Prieto, who works at the EOC is currently our ERT/EOC liaison and keeps us informed of the progress being made there. This is all very exciting and has been a long road. It will likely be even longer, but worth it. Collaborating with Animal Control and the OCFA has been challenging and rewarding. I am flattered at the confidence both agencies have in us, and when it all comes together it will be well worth the time and energy. Thanks again for the support of all ETI members who share in this effort, especially those in MAU. If all goes as planned, you will have a report next month outlining the outcome of the July meeting. In the meantime, stay cool
