THE BEGINNING OF THE END? AN EDITORIAL ON THE SADDLE CREST PROJECT BY JAMES M. IACONO

I tend to spot over-dramatization from a mile away. It's not an effect that I gravitate towards. In fact, in most cases it pushes me to the other side of the argument. But the more I looked into the changes Rutter Development wants to push through the County Codes and Specific Plans for the development of their pet 65 home Saddle Crest project, the more I realized this could be a hinge point in the history of Orange County. To say that this could be the beginning of an end to life as we know it, is not overly dramatic. It may not happen tomorrow, next year, or even in our lifetime. But all societal trends have a beginning, and unless that beginning is quashed, it can create a bulldozer of momentum that will change the face of the Saddleback foothills for future generations.

Specifically, I must challenge the proposed amendments to change the wording of the Foothill Trabuco Specific Plan and the Orange County General Plan to remove the words rural and natural. After all, these documents were created, in part, to protect those very things. The applicant has called the language in the FTSP outdated since only ten building permits have been issued since its inception 20 years ago. I am the holder of one of the ten issued permits. I think I speak for all who have gone through the FTSP process that we find it an insult and a slap in the face that the rigorous yet necessary regulations that we were forced to abide by can now be swept in the closet forever by a special interest group unwilling to modify their project to fit the terms of the plan... a plan I might say they were well aware of when they purchased the property. I knew the rules when I bought, and I worked with the FTSP Review Board and the Planning Commission to create a home that is not only consistent with the plan, but is consistent with a community that is proud of its heritage. The FTSP was meant to preserve a lifestyle and a heritage this applicant wishes to change forever. For what? For 65 homes? For other land they have set in their sights? A famous quote is apropos here... "What good is it if a man gains the world, but forfeits his soul?" And that's what we are talking about when we remove the words "natural" and "rural" from this area. Those words are the soul of the foothill commu-

nities. Those words need updating? Who can be bold enough to say that the nature God has created needs updating. I am afraid they are in our midst.

You know, this County has long attracted famous people who appreciated the open spaces and the rural lifestyle. John Wayne and Gene Autry could well have afforded to live in LA, closer to the entertainment hub with which their lives were intertwined. But they chose to lay roots here in Orange County where there were orange groves, riding trails, ranches... a rural lifestyle. Much has changed, concrete has paved over many of the orange groves. We have one slice of the county where we wish to preserve a rural lifestyle by protecting the nature that has since dwindled since the early days of this beautiful county. Are we to lose forever an identity that has been in place for a couple of centuries? I am one of those people, and I know there are several thousand of us, that have gone to great lengths to acquire a lifestyle that speaks to our nature, that speaks to some roots deeply and inherently part of our makeup, that wishes to hold on to a simpler life. A life in which kids can go grab a fresh egg in the morning from the bottom of a bantam hen, where they can raise a pygmy goat from birth and show him at the county fair, where they can set aside a video game remote and go to bed early so they can watch their gray mare push forth a foal in the dim light of dawn. This is what's at stake when we are asked to sacrifice an entire culture for a handful of tract homes, whose developer refuses to build and blend, but instead tear down and tear up a document that has helped preserve a life threatened now by extinction. As a group, we have to demand that our elected officials stand tall and put a halt to a classic case of the tail wagging the dog. To stand by and let these amendments pass will be a turning point in the history of this county. The beginning of the end to a lifestyle that at one time was our signature.

The famous Chick Hearn used to call out the Lakers when they were easily being scored on that they were employing the "matador defense." That is where the matador simply waves his cape and lets the bull charge by. We must not say "ole!", but say "No Way" to these soul-stripping amendments.



FIRE SAFETY: AUGUST TIP No.8

As we approach the most critical heat related weather patterns of the year; this is a good time to review how we can prepare for extreme weather and keep ourselves, our pets, and our homes safe. Living in a wildfire threat area of California, it is good to recognize and respond to fire weather warnings. We often hear on the radio when a fire weather watch or warning is issued and this is something we should not ignore. If you are part of an organized Fire Watch program, you may receive emails, texts, or phone calls advising you of a possible weather event and the need for volunteers to be ready to activate. The main weather patterns that will prompt a watch and put us at the greatest risk are high temperatures partnered with low humidity, high winds (15 mph or more), and dry vegetation which give fuel to a growing wildfire. An additional risk is dry lightning strikes.

These are all conditions we cannot prevent. But if we understand wildfire behavior and prevention we will be in a better place to control our environment. When the pattern is present and the above conditions exist, the National Weather Service will issue a Fire Weather Watch to CALFIRE who will in turn alert regional agencies of the situation. In Orange County; the OC Fire Authority will notify their various Fire Watch programs to prepare to organize volunteers to activate their patrols. A Fire Weather Watch means extreme conditions may exist within the next 12 to 72

hours. Volunteers may be notified but not activated. If the watch escalates to a Red Flag Warning (extreme conditions will exist within 24 hours) volunteers will be activated and fire stations will be directed to display Red Flag Alert banners at designated locations throughout the county. You may see volunteers with magnetic signs and green vests displaying the Fire Watch emblems on them. These are your neighbors keeping an eye out for threatening conditions or activity that may result in a vegetation or wildfire.

In anticipation of these conditions, defensible space of 100 feet of your home and structures should be made. Wood and hay should be stored away from buildings. Plants, trees, and shrubs should be well trimmed. Eaves should be free of leaves and debris.

We have no control over the weather. But we can prepare in advance for the best possible outcome. Below you will find the websites referred to here and additional resources to help you be ready for the warm summer ahead.
